# Brief History of the League of Women Voters: Springfield

## Chapter

The League of Women Voters is a nonpartisan group that encourages citizens to be informed about political issues and to have active participation in the political process. The group seeks to give nonpartisan information on candidates and issues on the local, state and national level. This group is organized into national, state and local levels. The LWV studies issues that affect the community and strive to create solutions that will better the community as a whole. Springfield's chapter was active in making the city a better place for all citizens by encouraging involvement in elections, housing, juvenile justice, children's service, education, the environment, city finances, taxes, and public safety.

- The national LWV was founded in 1920, the year that women's suffrage was written into the Constitution. It was born out of the National American Woman Suffrage Association.
- The Springfield chapter of the LVW was established on April 8<sup>th</sup>, 1930. The first meeting was held at the Shawnee Hotel. The first local president was Mrs. Stuart Tatum
- The group was active from 1933 until it slowly began to dissolve in the 1980's and ceased activity in 1992. Members were given the option to join the Dayton and Columbus area chapters when the Springfield group dissolved. Members were encouraged to keep active on the state level.

All information present in this brief history comes from files in the collection.

## Scope and Content

The collection of the Springfield, Ohio chapter of the League of Women Voters is divided into ten series: (1) History; (2) Administrative Records; (3) Newsletters and Publications; (4) Local Issues and Programs; (5) State Issues and Programs; (6) National Issues and Programs; (7) Clippings; (8) Audiovisual; (9) Scrapbooks; and (10) Photographs. This collection is housed in 15 boxes containing 505 files. Included in this collection are several artifacts that are kept separate from the paper documents.

Series 1 contains folders on the leagues history. This is a small series that contains only two folders. This series gives the reader the most basic information on the Springfield League of Women Voters.

Series 2 contains the Springfield chapter's administrative records. The subdivision in this series are the LWV Organization Information, Finances, Bylaws, Conventions and Conferences, Membership: Member List, Membership: Development, Membership: Other Chapters, Meetings: Board, Meetings: Annual, Meetings: Minutes, Board Memo's, Publications, TRY (They Represent You), Publicity, Skits, Correspondence, Office, and Miscellaneous by Date. There is local, state and national information contained in this category. The information in this section is patchy. There are holes and missing information on minutes and membership lists. This portion of the collection occupies 4.5 boxes.

Series 3 has copies of the newsletters produced by the League. The Local Voter, Local News bulletins, State Voters and News Bulletins, and The National Voter are represented as subdivisions in this section. The local bulletins are great resources for finding out what issues the local chapter was interested in at a particular time. They have information regarding League activities, political issues and other items of interest to the League. There are gaps in the copies of all publications. Dates were added to the title folders in this section to make navigating the series easier.

Series 4 consists of local issues and programs; this section is divided into the following sub series: Elections, County Government, City Charter, City County Facilities, Taxes, Clark County Building, Zoning, Housing, and Planning, Clark County Community Information, Adult and Juvenile Justice, Environment, Education, Social Programs, LWV Local Programs, Library, and Miscellaneous by Date. This is a massive

portion of the collection occupying 4 boxes. In this section you will find information on local elections, candidates, local studies and other concerns that affect Springfield and Clark County directly.

Series 5 is the state issues and programs. This series contains much of the same type of information that is found in the local issues and program series. This category is broken up into the following sub series: Elections, State Finance, Ohio Government, Ohio Judges, City Governments, Environment, Education, Social Programs, State Programs, Public Safety, and Miscellaneous by Date. There are 2 boxes on information on state issues.

National issues and programs, series 6, covers national and some international topic related to the League. This category is divided into ten sub series. These are Congressional Information, Foreign Policy, Labor Relations, Voting Rights, National Defense, Environment, Social Programs, National Programs, Public Safety and Miscellaneous by Date. This section is great for learning about public issues that the League found important. It shows how local concerns are affected on a national level.

Series 7 contains most of the news clippings in collection. These clippings cover local, state and national issues from 1946-1984. Most of the articles are from local newspapers. There are many articles on the Leagues participation in the community. This part of the collection was placed together because of the diversity presented in each folder and the need to keep the original contents of each folder together.

The audiovisual series, series 8, contains slides and audiotapes. There is an audio lecture that is accompanied by slides. There are also two different sets of pollution slides. This is a very small part of the collection that is housed in it's own box.

Series 9 is composed of scrapbooks. There are four scrapbooks in this collection housed in an oversized box. They cover the following years: 1952, 1954-56, 1957-58, 1958-63. This scrapbooks have articles on the Leagues activities and community issues.

The final series in the collection is photographs (series 10). This part of the collection is kept with the photograph collection. All the photographs from this collection are in one folder. There are not very many and are mostly from the same event.

This collection came to the Clark County Society in 1996. The condition of the collection upon receipt showed no organization either by date or subject. In 2005 the collection continued to be processed and was broken up into categories that reflect logical divisions of subjects. In a push to keep these records consistent to other League records, I have tried to organize them in a way that is similar to other League of Women Voters collections, and also reflect the standards of the CCHS.

The collection was re-folded using original titles on the folders. In some cases dates were added to the title in order to make the contents more obvious. There are cases where the contents on the folders do not reflect the title, these folders were organized based on content instead of folder title.

This collection tends to be heavily weighted with information from the 1970's. There is information from the 1930's through 1960's, however this information is much less dense than that from the 1970's. The information from the late 1980's through the demise of the Springfield chapter is fractioned. The information that is lacking can be attributed to many things, including purging documents and poor record keeping. Perhaps there will be additions to the collection to make some of these records more complete.

The information in this collection is very similar to other League collections. This one does seem to have fewer scrapbooks than other collections. This comes as a surprise seeing as women's organizations tend to keep detailed scrapbooks. The scrapbooks present only represent one decade. There are also very few photographs. The photographs that are represented seem to be from one event in the late 1970's.

This collection is useful to understand the political and social climate of Springfield, Ohio from 1930 through 1992. It has very detailed information on members of the community that were active in the political process. This collection is also valuable in learning about the role of women in the political process. It teaches about the major milestones that women have achieved from the suffrage movement to the end of the twentieth century.
